# **DIACC Proof of Concept #3 - Launched**

Accelerating the development of world class innovative solutions that Canadians can use with confidence requires the establishment of a high regard of trust in the identity ecosystem of people, organizations, and things.

POC #3 - Distributed Ledger "Blockchain" Proof of Concept for Corporate Registries - represents a significant step in addressing the needs of organizations. The first sprint (sprint one) will demonstrate how using the technology behind Blockchain's HyperLedger can provide visibility and transparency into Corporate Registry transactions between multiple Provincial Jurisdictions.

To provide context and relevance to POC #3, the following question statement was used - Is there a way to decrease the effort and improve the experience of both registrars and businesses by leveraging Blockchain distributed ledger technology?

DIACC hosted a Federation Innovation Workshop on Nov. 2nd & ID International Industry Day Nov. 3rd at the Adobe Conference Centre, Ottawa. The events attracted over 100 delegates from across Canada and around the globe.



The ID Federation Opportunities Workshop connected innovators from the public and private sectors to share perspectives regarding the emerging digital ID ecosystem.

The ID International Industry Day converged public and private innovators from Australia, Canada, Denmark, Israel, Japan, the United Kingdom, and the United States to share perspectives in order to accelerate the establishment of a privacy-respecting digital ID ecosystem.
